5.1 Special Board Report No. 40: Tender for Geraldton Hub Project

Manager of Plant Services Marc Paris provided a review of the Geraldton Hub Project. He advised that a tender for the construction of the GCHS-BAPS Childcare addition, interior alterations and site improvements had been advertised on MERX. The lowest tender bid that met all the requirement of the specification, was submitted by M-Builds (NWO) Limited, in the amount of \$9,121,000 before HST. Consultation with the Ontario Government Capital Branch Analyst, Financial Analyst and Childcare Analyst was undertaken to secure additional funding. The additional funding needed has been secured and the Geraldton Hub project is ready to proceed with awarding the project tender.
