He noted that currently 27% of the student population accesses special education support. It is recommended that for 2018-2019, 40.0 EAs be funded through Board and Special Education Funding and an additional 6.0 Educational Assistants be funded through First Nation Service Agreements for a total of 46 Educational Assistants.

The lowest tender bid, which met all the requirements of the specification was submitted by Rugged Air Industries Limited in the amount of \$713,000.00 before HST. In accordance with purchasing policy 303, Board of Trustees approval is required when purchase limits are over \$500,000.00. Funding of the project is supported by the Ministry capital funding allocation through the School Condition Improvement (SCI) grants.
