His address articulated support for maintaining the LSHS Dual Campus and relocating the Superior-Greenstone DSB to the LSHS Schreiber Campus.

Chair, B. Bartlett advised that the Administrative Summary Report and the LSHS Dual Campus Review Committee Report would be presented consecutively with questions taken for clarification after each.

Report No. 16 – 01/02: Administrative Summary Report 7.1.1 for the Lake Superior High School Dual Campus Review Director Heather Wilson-Boast reviewed the Administrative Summary Report with supporting details and/or scenarios in conjunction with the information contained in the report. A section of the report dealing with program flexibility and access to more credit options available in a single campus environment was illustrated in a PowerPoint presentation. In addition two points made in the previous Administrative (Special Board) Report were clarified. That is, science courses are not currently duplicated at both campuses, but rather the science lab space presents as duplication. In regard to the facility cost savings to be realized in a single campus environment, it was noted that the figure of approximately \$160,000 as noted is approximately \$140,000 when reduced to its net terms. Also noted was that to deem the LSHS Schreiber Campus surplus was not synonymous with disposal of the property/facility. A surplus declaration does not automatically initiate the act of disposal or sale of the property. It permits a Board to exclude the unused capacity numbers from its budget estimates. The recommendation from administration was to locate LSHS to Terrace Bay and to deem the Schreiber Campus of the LSHS surplus to its needs, effective August 31, 2002.

7.1.2 <u>Lake Superior High School Dual Campus Review Committee</u> Response and Final Recommendations

Mike King, Cathy Carlino and Don McArthur of the Dual Campus Review Committee each presented a summary and response to the Administration's recommendation to locate LSHS in Terrace Bay and declare the Schreiber Campus surplus. Both Mr. King and Mr. McArthur reiterated that the Dual Campus Review Committees' recommendation to retain the Schreiber Campus facility to house the Grade 9 students. As well, the facility could be used to house the staff and offices of the Superior-Greenstone DSB. It is their contention that it is the best alternative solution for the reality of declining enrolment. If this solution was not amenable to the Board, then each challenged the Board to collect more data to facilitate a more thorough study prior to reaching a decision regarding the review.

Ms. Carlino advised that she had personally conducted a comprehensive review of the LSHS Student Surveys distributed early on as a component of the Dual Campus Committee's Review because the survey and how it was evaluated had always been a concern for her. It was noted that 167 of 247 surveys were returned and that the survey was not developed as a scientific instrument of discovery. Rather, it attempted to solicit a sense of what the students were feeling about their current environment and their feedback about various school scenarios and the impact on them. Students did not articulate majority support for a single LSHS campus. Rather, 99 of 167 respondents indicated a need for change, for an opinion rate of 36%. In addition, Ms. Carlino presented correspondence from the Student Representatives on the Committee on their behalf. This correspondence outlined the perceived difficulty seen as a result of a change to a single-campus environment and articulated support for keeping both campuses open.
