A significantly successful outcome is reported for the past year's pilot project, where half-time Literacy Teachers have been on staff at the Red Rock, Dorion, Margaret Twomey and Terrace Bay Public Schools. The analysis of the quantitative data demonstrates that virtually, every student in the schools that were provided a Literacy Teacher has improved in reading. The Board is committed to ensuring that every student is a reader by the end of grade three. Approved staffing for the 2002-2003 school year has seen the addition of dedicated literacy teaching staff to ensure that this expertise is available in all of our elementary schools.
