The Manitouwadge Public School Council requested board consideration to busing all JK to Grade 3 students and dispense with distance eligibility criteria. This was denied. A significant cost is associated with its implementation and this direction in Manitouwadge would require equitable practice in all other communities. This would see the creation of a deficit of about \$258,000 in the transportation department.

Correspondence to the Township of Manitouwadge will be forwarded to request that its municipal pedestrian walkways be fully serviced and maintained for safe student passage to and from the schools that SGDSB students attend in Manitouwadge.

Approval was given to revise Policy 301bus eligibility criteria to include home to school transport for all students who are required to walk to school via a public roadway that intersects with an active railroad crossing.

The board suggested that a survey be taken to attempt to determine the degree to which parents' desire to have bus transportation impacts their decision about enrolling their children into the public or separate schools in communities.

The Board Policy Committee will be asked to review Policy 301 Management Guidelines to include reference and parameters to address Bill 73 Booster Seats legislation, and furthermore address this reference in Policy 302, Student Transportation by Staff or Other Volunteers.
