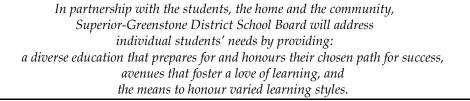

This short-term intervention program is designed to engage students in literacy learning experiences to acquire the necessary knowledge, attitudes and strategies to function as independent readers and writers. George O'Neill and B.A. Parker and Marjorie Mills Public School each run the program for grade 7 and 8 students. A summary of the progress and outcome of the program was reviewed. Feedback from students is

encouraging with 83% of them reading more than 20 minutes outside of school. A proposal to expand the program into three more elementary schools has been submitted to the ministry.

Terry Ellwood provided a report on the Aboriginal Forum held in Thunder Bay on January 19 and 20, 2006. The forum, attended by about 150 delegates was convened in association with the NOEL. Superior-Greenstone DSB had nine delegates there including four trustees. Cindy Fisher and Terry Ellwood facilitated a session on the process for establishing a board First Nation Advisory Committee. Trustees C. Fisher, K. Notwell. L. Aylward and Board Chair, B. Bartlett each provided a brief personal perspective as delegates in attendance.

Update: Facing the Truth Conference 13.3

On January 21 and 22, 2006 the Grade 12 Canadian and World Issues Geography Class of Nipigon-Red Rock DHS convened a session entitled "Face the Truth – A Youth Conference Confronting the Crises Impairing Northwestern Ontario. The two-day event held at the high school was attended about 110 people. It featured discussion groups with the regional members of parliament, community dignitaries, regional high school classes and the general community. The impact of poverty and racism, globalization, the software lumber crisis, youth migration and tourism in the region were among the issues addressed. Director, Terry Ellwood extended congratulations to the both the students and their teacher Jennifer Rissanen for the success of the project.

Patti Pella provided a brief update on this ministry initiative to create more child care spaces for children in the province. The Ministry of Community and Social Services and the Ministry of Education, in a partnership approach have a goal to enhance childcare space by creating seamless service hubs linked with community schools. School facilities designated with these spaces would be referred to as a regional hub. The business case presented for this board has resulted in the addition of 38 child care spaces in our region and accompanied by capital fund approval of \$295,000. The next phase of the process involves identifying where the spaces will go in our region. Steering committees that have been established are continuing with regional consultation to identify the most opportune sites for the location of the regional hubs. A written report on progress to date will be submitted at the February board meeting.
