Patti Pella reported that on October 31, 2006, the Ministry of Education released Pupil Accommodation Review Guidelines which were previously referred to as school closure quidelines. The Pupil Accommodation Review Guidelines are designed to provide direction to school boards regarding public accommodation reviews undertaken to determine the future of a school or a group of schools. The Pupil Accommodation Review focuses on School Valuation and includes a formal process to consider four values when a school is being reviewed. In school reviews for closures, boards are expected to develop a Generic School Valuation Framework that assesses the value to the student; value to the community; value to the school board and value to the local economy. On February 5, 2007 with the assistance of a public committee including parents, educators, board officials and business and municipal leaders the SGDSB School Valuation Framework will be developed and a further review will follow by the Board Policy Review Committee.

Student achievement and the Directors' of Education accountability in this area was also a focused discussion. She advised Board members that she addressed the Minister on the subject of challenges faced by small boards in light of declining enrolment and the fact the in northwestern Ontario there is a serious downturn in the forestry sector and non-renewable resource industry such as mining. She said she stressed the need for adult retraining and situation that declining enrolment may contribute to classroom configurations that could see triple and quadruple grades result.
