

Ms. Wiskin reviewed the EQAO results in math and literacy noting that work in areas to improve the applied math scores continues. She reported that in the academic math stream MRHS is above the board average, while in literacy streams student averages are above both the board and the province scores.

In the second part of the presentation, Katherine Inwood provided a slide presentation with narrative on school's Alternative Education Program. Mrs. Inwood reported that of 275 course starts in 2006-2007, there were 181.5 credits granted or a 66% success rate.
